Viewing Sun 8.00am till auction starts 10.30am

- Floor Bidders must register at the viewing or on the auction day with a BACWA buyers number. Whilst all care is taken, neither BACWA or the Auctioneer accept responsibility for items described incorrectly either in the auction listing or at the auction. Bidders who wish to purchase items should take advantage of the viewing hours prior to the auction commencing to view and inspect desired items.
- Absentee Bidding forms **MUST** be received by 10.00am WST Sunday 12th April 2026. Postal, telephone and email bids will be accepted until 10.30am on the auction day. (ie must be received by 10.00am on 12th April 2026) All successful postal, telephone and email bidders will be notified by email. Such notification will include information in regard to postal and packing charges (to cover costs such as bubble packing, wrapping paper, etc.) together with postage.
- The purchaser is to be the highest bidder. Any dispute arising as to the highest bidder is to be determined by the Auctioneer who may re-offer any disputed lot for sale. The Auctioneer reserves the right to refuse any bid or to bid on behalf of clients
- There will be NO Refunds or Returns. All lots sold-as-found.
- The Auction Absentee bid co-ordinator (Richard Boyd) will inspect any lots on behalf of bidders who wish to lodge their bids by post, telephone or email to ensure that the lots are as described in the catalogue. Absentee bidders will be assigned a BACWA bidders number for their reference and use if they then decide to bid by phone or live in the auction rooms.
- The Auctioneer is merely the agent of the vendor in respect of the sale of goods. The Auctioneer shall not be liable for any default of the purchaser or vendor. The Auctioneer shall not be liable for any loss or damage to the goods left in his care by vendors or purchasers. The Auctioneer gives no warranties in respect of these matters and no lots are to be returned to the Auctioneer.
- All Floor purchased items must be paid for and collected on the day. Payment by cash or EFTPOS is preferred however, cheques will be accepted with prior notification and approval by BACWA.
- Successful Absentee Bidders will be invoiced within 24 hours and payment is to be made within 7 days.
- A 7.5% Buyers Premium will be added onto the total amount of purchase, e.g. winning bid of \$100 will increase to \$107.50, to cover the use of systems, technology, premise and admin for this auction.
- All paid for items will be collected by delegated BACWA Auction Officers upon receipt of a PAID invoice at the end of the auction.
- BACWA or the Auctioneer reserves the right to withdraw any item listed for auction at any time.
- BACWA or the Auctioneer reserves the right to refuse a bid or accept a bid by a bidder at any time.
- Some auction items have reserve prices. These reserves have not been printed in the catalogue.
- An estimate has been supplied for each lot. This is **only an estimate** made by committee members, to the best of their knowledge as to what the item would expect to fetch on the open market in the condition as listed.
